PLANT HIRE TERMS AND CONDITIONS

MINIMUM HOURS

- * Minimum 9 Hours per Day.
- * Minimum 21 days per month
- * Hours worked over and above minimum hours will be charged pro-rata.
- * Standing Time 100%
- * Inclement Weather 50%

ORDERS

- * Rates based on availability of, not usage of machine; i.e. hour meter hours not applicable
- * Establishment and De-establishment will be charged on the first invoice
- * The item will not be delivered unless the quotation, Credit Application and terms and conditions have been completed, signed and returned to us.
- * Should you not have an account with Elevate Hire, a prepaid account will be opened; i.e. Payment must be done in advance in order for work to commence.
- * We require an official order, together with the signed copy of quotation prior to commencement of work.
- * The hirer is to allocate a supervisor to supervise and advise the operator on the conditions of the area of work.

OPERATORS

- * An operator will be provided by Elevate Hire. The accompaniment of an operator will not affect the rate of hire.
- * The operator whilst on site shall be under the sole supervision of the Hirer and shall be under their guidance and instruction.
- * The Hirer shall not permit any person to operator the plant other than the allocated company operator.
- * Time sheets/Plant Returns are to be faxed through to our offices on a weekly basis in order for invoicing to be done promptly and the operator to be paid correctly.
- * The operator's transport and accommodation is for the hirer's account.

BREAKDOWNS

- * Breakdowns need to be reported immediately to our Breakdown Department on 071 412 5263
- * Ensure that the correct quality of diesel is used, damaged caused by inferior products will be for the hirers account

GROUND ENGAGING TOOLS (GET's)

- * All GET's are for the hirers account
- * No deduction of hours will be allowed when changing of GET's
- * GET's to be checked daily by Hirer

I IARII ITIFS

- * The Hirer is liable for any damages caused to our plant/vehicle/equipment due to the Hirer's negligence
- * The Hirer is responsible for the safety and security of our plant / vehicle / equipment while on hire.

INVOICE QUERIES

- * Queries on invoices will not be entertained later than 10days from Statement
- * Payment to be no later than 15 Days from invoice net.
- * Interest will be charged at 5% per month on all overdue accounts
- * Accounts must be up to date in order for NEW orders to be fulfilled
